Increased communication between the North Fulton Bar Association and our local State Legislators

On October 18, 2006, the State Bar of Georgia hosted a meeting of the Local Bar Activities Committee. Invitees

included Presidents of the Local and Circuit Bar Associations. The meeting stressed the State Bar's interest in involving lawyers with State legislators. Presentations were given by the State Bar President, lobbyists for the Georgia State Bar, and by Chuck Martin, State Representative for Alpharetta's District.

The State bar emphasized the point that only about 1/3 of State legislators are attorneys and indicated that as a profession we need to stay in touch with our local legislators and keep them involved in our activities.

Suggested activities included including state legislators in our holiday parties and barbecues, forwarding copies of our newsletters to them, meeting over lunch with them in an informal setting, keeping them advised of mock trial events, and encouraging them to speak to the local Bars. It was emphasized that the education of non-lawyer legislators to issues important to the judiciary and the legal profession should be a high priority.

To further the State Bar's efforts in this area, we are going to try and get the North Fulton Bar more actively involved with our state legislators. In furtherance of this, the Board will try and meet with them on an occasional informal basis, we are going to begin to invite them to our meetings, and will begin to provide them with our newsletter. Any efforts on the part of individual members would also be appreciated.

Increased communication between the North Fulton Bar Association and our local State Legislators

On October 18, 2006, the State Bar of Georgia hosted a meeting of the Local Bar Activities Committee. Invitees included Presidents of the Local and Circuit Bar Associations. The meeting stressed the State Bar's interest

in involving lawyers with State legislators. Presentations were given by the State Bar President, lobbyists for the Georgia State Bar, and by Chuck Martin, State Representative for Alpharetta's District. The State bar emphasized the point that only about 1/3 of State legislators are attorneys and indicated that as a profession we need to stay in touch with our local legislators and keep them involved in our activities. Suggested activities included including state legislators in our holiday parties and barbecues, forwarding copies of our newsletters to them, meeting over lunch with them in an informal setting, keeping them advised of mock trial events, and encouraging them to speak to the local Bars. It was emphasized that the education of non-lawyer legislators to issues important to the judiciary and the legal profession should be a high priority. To further the State Bar's efforts in this area, we are going to try and get the North Fulton Bar more actively involved with our state legislators. In furtherance of this, the Board will try and meet with them on an occasional informal basis, we are going to begin to invite them to our meetings, and will begin to provide them with our newsletter. Any efforts on the part of individual members would also be appreciated.

NFBA Community Service Opportunities

The NFBA Board of Directors is exploring various ways that our members can contribute to the community. One suggestion was to develop a program where firms or solo practitioners could donate outmoded or used computers, monitors, etc. to needy individuals or organizations.
